

SUMMARY OF CEMETERY RULES & REGULATIONS

These rules and regulations are designed to preserve the appearance and dignity of the garden and mausoleum areas at Washington Memorial Park & Mortuary, Inc. ["Cemetery Authority" or "park"]. They are intended to honor the lives of those memorialized here.

GENERAL GUIDELINES

- ☐ Visiting hours for the cemetery grounds are:
 - Cemetery Grounds: 8:30 until Dusk
 - Mausoleum: 9:00 AM – 5:00 PM (Monday to Saturday)
10:00 AM – 3:00 PM (Sunday)
 - Office Hours: 9:00 AM to 5:00 PM (Monday to Saturday)
10:00 AM to 4:00 PM (Sunday)
- ☐ Personal temporary enclosures/canopies/tents are not permitted.
- ☐ Food and/or alcohol are not permitted in the park.
- ☐ Personal vehicles should not impede road access. Park staff may require you to relocate your vehicle if it causes an obstruction.
- ☐ To respect the resting places of others, please refrain from obstructing adjacent graves when visiting your loved ones.
- ☐ Vehicles in the park shall observe a speed limit of 15 MPH.
- ☐ Keep purses and other valuables locked in your trunk.
- ☐ All trees, shrubs and plantings are the property of Washington Memorial Park & Mortuary, Inc. Plantings by individuals are not permitted.
- ☐ Pets are not allowed in the park except for trained guide dogs or when kept in automobiles.
- ☐ Funeral flowers will be removed when they become unsightly.
- ☐ All grave decorations will be removed and discarded 7-14 days after each holiday.

MEMORIAL GARDENS

- ☐ Floral receptacles shall not be placed on any plot unless first approved by the cemetery authority and when placed, shall remain subject to the rules and regulations of the park.
- ☐ No enclosure of any kind shall be permitted around any plot or lot. The placing of articles such as balloons, pinwheels, planter boxes, souvenirs, photographs, glass, decorative rocks or preserved flowers is prohibited. Such items will be removed and disposed of by park personnel.
- ☐ Artificial flowers are only permitted during the non-mowing season. Any artificial flowers that are placed on graves during mowing season will be removed and disposed of by park personnel.
- ☐ Fresh cut flowers are allowed in the park at all times in regulation vases and will be removed and disposed of by park personnel when they become unsightly.
- ☐ Non-permanent vases are not allowed.
- ☐ Permanent vases are available for purchase through the office and will be installed by the park.

MAUSOLEUMS AND COLUMBARIUMS

- ☐ Urns, inscriptions, name plates, fittings, and adornments for crypts or niches shall not be placed unless first approved by the cemetery authority. If permission is not received, they will be removed and disposed of by park personnel.
- ☐ Fresh cut flowers and artificial flowers are allowed at all times in regulation vases. They will be removed when they become unsightly.
- ☐ As a courtesy to others, please limit the size of floral arrangements so they do not encroach on adjoining crypts and/or niches.

MAINTENANCE REQUESTS

We strive to maintain the cemetery at all times. However, should your grave spaces, memorials or vases require maintenance, please stop by the office and complete a Service Request Form. Alternatively, you may contact our staff at (206)242-1787.
